Position Summary

Assesses and treats acute, episodic or chronic illness, independently for all inmates of the Karnes County Jail.

Working Conditions

May frequently be required to walk; sit; climb, balance, stoop, kneel, crouch or crawl, use hands to finger, handle, or feel; reach with hands and arms; and talk or hear. Ability to lift, carry, push or pull objects that weigh 200 pounds with or without accommodation. Specific vision abilities required by this job include color vision, close vision and distance vision. Use of personal computing equipment, telephone, multi-functioning printer and calculator. Employee may potentially be exposed to hazardous chemicals, wet or humid conditions, outdoor weather, noisy and dusty environment. Periodically exposed to persons who represent a danger to health and life. Ability to operate a motor vehicle and travel within Karnes County and surrounding areas. May witness unprofessional or inappropriate conduct by visitors, family of inmates or inmates. May be exposed to bodily fluids such as blood, exposure to contagious diseases such as TB and exposure to stressful conditions. May be required to work after hours.

ESSENTIAL FUNCTIONS

Job Function

Manages and verifies and provides care for the medical concerns of all the inmates incarcerated in the Karnes County Jail.

Analyzes and interprets patients' histories, symptoms, physical findings or diagnostic information to assist in developing appropriate plans of care.

Implements appropriate prescriptions based on written protocols, verbal orders, or written orders per the facility prescriber for medication dosages, routes and frequencies based on patient presentation.

Documents on medical encounters that require nursing measures and relays information to facility provider either via progress note, text, or verbal exchange on a county phone.

Performs other duties, special projects and assignments as assigned.
